## **FAIR TRADE NEWS:**

Nestle have announced that from October their Kitkat bars will no longer carry the fair trade mark. Currently both the cocoa and sugar in the bars are bought on fair trade terms and the payment of the fair trade premium has made a huge difference to farmers in West Africa and elsewhere.

Nestle are introducing a Cocoa Plan and buying sugar beet from Europe which will leave sugar cane farmers without this market. The news comes at a time when farmers in the global south are struggling to cope with the Covid 19 pandemic.

Cocoa farmers in West Africa earn on average 74p per day, little more than ONE Kitkat bar.

Ivorian farmers have written a letter to Nestle, expressing their huge anxieties over the move, which you can find on the Fairtrade Foundation website.

On visits to fair trade producers in India, Phil and I heard more than one producer group lament that the fairtrade mark is being devalued by the inclusion of large companies who are not 100% committed to the movement. Sadly Nestle, following Cadburys and Sainsburys, rather prove their point.

Please show you care in whatever way you can:

Read the full report on the Fairtrade Foundaton website.

Don't buy Kitkat bars and where possible avoid other Nestle products.

If you feel able, write to Nestle CEO in Britain to say why you are not buying their products. Address: 1 City Place, Gatwick, RH6 0PA.

You can make a positive swap to fair trade items and the Traidcraft online shop is well stocked with sweet treats.

News from Wolverhampton Fair Traid: Many thanks to churches who managed to sell Easter Eggs before lockdown. Wolverhampton Fairtrade is not currently open although I have been able to supply some loyal customers who are desperate for their chocolate fix!

In Fairtrade Fortnight the shop had stalls in the Mander Centre and the Civic Centre where trade was brisk and we were hopeful of better things to come. That seems like another world and it is too early to share with you our plans for the future.

Of course, grocery items have a limited shelf life and we have been able to support the Good Shepherd Ministry by offering them food items which were nearing their 'best before' dates. We are due to take a third parcel sometime this month.

We hope it will not be too long before we are able to work with you again.

Brothers Charles, Stephen and William have written the introduction for this as it was the Brothers' vision which started the Good Shepherd many years ago and has underpinned our values and desire to support the marginalised and vulnerable in society ever since.

The last few months have been difficult and challenging for so many individuals for so many different reasons and the Covid-19 pandemic has meant we have had to change the way we do things.

The Good Shepherd is currently running without volunteers and are concerned about how we would cope with a large volume of items coming in and the small areas we have to sort stock. We would also like to change the way we support families and incorporate fresh produce in the food we distribute with suggestions and ingredients which will enable many to cook a variety of healthy meals.
